What is BRICS CCI?



Brazil, Russia, India, China and South Africa (BRICS) are the new emerging world economies and the leading political powers. The acronym BRICS was originally coined in 2001 to highlight the exceptional role of important emerging economies and the then acronym included Brazil, Russia, India and China (BRIC) only. It was pointed out that high growth rates, economic potential and demographic development were going to put BRIC further in a lead position and it was argued that their increased relevance should also be reflected in their incorporation to the G7 (O'Neill 2011). The four countries first met as a group in 2006 and it was only in 2010 that South Africa was invited to join, after which the group came to be known as BRICS. Brazil, Russia, India, China and South Africa have emerged as 'the protagonists' in the world economy significantly and rapidly.

The **BRICS Chamber of Commerce & Industry** is an organization which promotes commerce and industry in the BRICS and other nations. The Chamber, founded in 2012, with the efforts of eminent professionals and entrepreneurs, is a not-for-profit and non-governmental organization. BRICS Chamber of Commerce and Industry (BRICS CCI) organized a conference on Goods & Services Tax – The Way Forward at the FORE School of Management, New Delhi with Achromic Point as Marketing Partner, Spliced Knot as Digital Marketing Partner, The Institute of Internal Auditors of India and Fore School of Management as Institutional Partners, Solicitors & Advocates Phoenix Legal and Shardul Amarchand Mangaldas as Knowledge Partners. The agenda was to provide a platform for comprehensive deliberation on the introduction of the new law. The conference commenced with a brief welcome note by Dr. B.B.L Madhukar, Secretary General of BRICS CCI. Mr. Navin Kumar, Chairman of GSTN, Mr. Bimal Jain, Executive Director, A2Z Taxcorp LLP, Mr. Sartgak Garg, Phoenix Legal and Mr. Sandeep Chilana, Partner, Shardul Amarchand Mangaldas also addressed the gathering on the provisions regarding Goods and Service Tax.

The main topics that were discussed were:

- GST – global overview
- Time of supply and place of supply
- Input tax Credits & registration under GST
- Implementation of GST
- GST preparedness

Being a destination based tax; GST requires robust settlement mechanism for inter-state trade. Hon'ble Dr. Justice Satish Chandra stressed on the need to prepare ourselves for GST. He spoke about Entry Dumping Duty, an indirect tax that most of us are unaware of and how Credits of input taxes paid at each stage will be made available. The discussion also covered the timelines for implementation and how the GDP of our economy will see a rise due to less tax evasion. Each state is expecting to collect more taxes on account of GST.

off. Mr. Pulkit Gupta, Director of Restructuring and Turnaround services extensively discussed the contentious issues under IBC 2016. Mr. Sajeve Deora, Director of Integrated Capital Services spoke about the liquidation process. His points of discussion covered the well defined waterfall mechanism. Hon'ble Mr. Justice Arjan Kumar Sikri, Supreme Court of India, expressed his views on the elements (efficiency, predictability and transparency) and the importance of balance between the creditor's rights and rehabilitation of the insolvent company. Mr. Hemant Sharma, Partner, Sastra Legal took the interactive session forward by elaborating bankruptcy for corporate, non-corporate and individuals.

The first ever North - East Green Summit 2016 was organised from November 1 - 5, 2016 at Tura, Meghalaya by VIBGYOR Media Solutions, Eastern Chronicle and North Eastern Hill University, Tura Campus and Don Bosco College, Tura in support with North East Zone - Cultural Center, Ministry of Culture, Govt. of India. Centre for CSR, BRICS CCI felt privileged to be associated to support this green cause. Dr. Sushi Singh, Convener, Centre for CSR, BRICS CCI, Chief Advisor, VIBGYOR Media Solutions & Vice President, Delhi Police Officers' Wives Welfare Society delivered an address on the concluding day on November 5, 2016. She stated that if we are to maintain a

decent living standard on the basis of our habits of high fossil fuels consumption, high energy intensity and irreversible changes in resources would leave us with a black & bleak future for our younger generations. She left a key message that it's time for strategically positioned North-East (once known for the richest Flora and Fauna) to send a clean and positive message to the world. North Eastern region, with strong political will, can proceed to have a green economy with conservation of art & culture only if all stakeholders of the society undertake measures to curb pollution by reducing carbon emission, preventing biodiversity loss, ecosystem damage and enhancing energy and resources efficiency.

BRICS Summit in Goa

(October 15-16, 2016)

The BRICS Summit 2016 was held in Goa where the leaders of the five nations participated to discuss a number of issues.

The summit adopted the 'Goa Declaration' covering a number of countries.

The summit was held at a time when India and Pakistan are at loggerheads over growing terrorist activities.

On the sidelines Prime Minister Narendra Modi also met the Sri Lankan President Maithripala Srisena and the Bhutanese Prime Minister Tshering Tobgay. The two leaders backed India's

firm stand against cross border terrorism after the Uri attack.

However India did not find the voice in Goa Declaration. PM Narendra Modi repeatedly raised the issue of terrorism during the meet. On the first day of summit, Modi targeted Pakistan calling it the mothership of terrorism.

He reiterated the stand and called on BRICS nations to come together and act against terrorism and the countries which are supporting it. China stated that Pakistan has made efforts to fight terrorism. On the other hand, Brazil softened its stand on India's entry to the Nuclear Supplier's Group (NSG).

Outcomes of BRICS Summit in GOA

- Memorandum of Understanding was signed for the importance of energy-saving and energy-efficiency for ensuring sustainable economic development.
- Agreed to organise a BRICS High Level Meeting on Traditional Medical Knowledge.
- Approval of the first set of loans by the New Development Bank (NDB), particularly in the renewable energy projects in BRICS countries.
- Establishing a Technology Facilitation Mechanism within the UN with a mandate to facilitate technology for the implementation of the SDGs.
- Using tax policy and public expenditure in a more growth-friendly way taking into account fiscal space available that promotes inclusiveness, maintains resilience and ensures sustainability of debt as a share of GDP.
- Welcomed the G20 Action Plan on the 2030 Agenda for Sustainable Development, adopted during G20 Hangzhou Summit and commit to its implementation by taking bold transformative steps through both collective and individual concrete actions.
- The advanced European economies to meet their commitment to cede two chairs on the Executive Board of the IMF. The reform of the IMF should strengthen the voice and representation of the poorest members of the IMF, including Sub-Saharan Africa.
- Commitment to support international cooperation, including in the Common Reporting Standard for Automatic Exchange of Tax Information (AEOI).
- India's offer to host a Conference in 2018 aimed at strengthening international resolve in facing the challenge of the WMD-Terrorism nexus was welcomed to address the threat of chemical and biological terrorism
- Signing of the MoU for Establishment of the BRICS Agricultural Research Platform to further intensify cooperation among BRICS countries in agricultural research policy, science and technology, innovation and capacity building, including technologies for small-holder farming in the BRICS countries.
- India, South Africa, Brazil and Russia convey their appreciation to China for its offer to host the Ninth BRICS Summit in 2017 and extend full support to that end.
- Called upon developed countries to honour their Official Development Assistance commitments to achieve 0.7% of Gross National Income commitment for Official Development Assistance to developing countries.
- Welcomed the substantive measures undertaken by the UN membership to make the process of selecting and appointing the UN Secretary-General more transparent and inclusive.
- China, South Africa, Brazil and Russia express their sincere gratitude to the Government and people of India for hosting the Eighth BRICS Summit in Goa.
- Endorsed the Goa Action Plan to strengthen our partnerships for common development
- The signing of the Memorandum of Understanding between the BRICS countries National Development Banks and the New Development Bank (NDB) upon recognising the increasing trade, business and investment between BRICS countries and the important role of BRICS Interbank Cooperation Mechanism.


